SUMMER FINANCIAL AID Regulations

ELIGIBILITY FOR SUMMER AID

In order to receive financial aid during the summer session, students generally must enroll at least half-time in an approved program of study. In some instances, students may be eligible for Pell grant funding at less than half-time enrollment. Half-time enrollment is at least six credit hours. Eligibility for summer financial aid is based on the information on the student's Free Application for Federal Student Aid (FAFSA) along with the student's financial aid history of enrollment during the 2017 fall and 2018 spring semesters. Summer aid applications are not processed until the BCCC Office of Financial Aid has received the results of the student's FAFSA and the verification process completed. A summer award can be rescinded if upon completion of the Satisfactory Academic Progress (SAP) for the 2018 spring semester, the student is deemed unsatisfactory.

YEAR-ROUND PELL

Students may be eligible to receive additional Pell grant funding for the summer semester, provided they have not exhausted their lifetime eligibility. Students must be enrolled in at least one class for the summer term if they did not exhaust their annual Pell eligibility in fall/spring, or **be enrolled at least half-time** in order to receive the Year-Around Pell grant offered for the 2017/18 academic year. SUMMER FINANCIAL AID AWARD NOTIFICATION

A revised award letter will be sent to your address on record once your 2018 summer Pell award is processed.

ENROLLMENT CHANGES

We urge you to consult with the Office of Financial Aid prior to making any summer enrollment changes. If your summer enrollment should change after your summer financial aid has already been disbursed, regulations may require BCCC to bill you for all or a portion of the summer financial aid you already received. **CERTIFICATION OF**
