## FORMS AND INFORMATION

The course preference form is included on page 11 of this brochure. You may obtain the BCCC Student Registration Form from our website. Both forms need to be completed and submitted prior to the weekend, along with registration fees. Forms can be mailed or faxed to our location. Please mark to the attention of Fire, EMS, or Law Enforcement Director. Classes are open to students age 16 and above. Our fax number is 252-940-6254.

### ENROLLMENT

Enrollment will on a "first-come, first-serve" basis. Students should make first, second, and third choices on their course preference forms. Every effort will be made to accommodate the student's first choice. All Live Fire Evolutions will be open to students over 18 years of age. Shooting Competition is open only to active law enforcement personnel.

### LOCATION

All classes will take place on campus unless advised otherwise at registration. Late registration and check in will take place in Building 10 Lobby. Follow campus signs to location. If overnight accommodations are needed, let us know and we will provide you with recommendations.

### REGISTRATION

All classes will be fee-waived for an affiliated member with any North Carolina Fire, Rescue, EMS, EM or Law Enforcement Agency (with the exception of cards for EMS offerings and a non-refundable \$10 event fee). 10 fee must be paid at the time of registration and is non-refundable. Please complete all forms necessary and return to us no later than February 23, 2018. If not associated with a department in Beaufort, Hyde, Tyrrell, or Washington County, please also provide a letter of affiliation with your department letterhead. If not affiliated, the registration fee will be \$70 per class plus \$10 non-refundable event fee. Late or walk-in registrations will be accepted if space is available. Classes with insufficient registrations may be canceled prior to the weekend.

## CLASSES

### 1. DRIVER/OPERATOR: PUMPS SPRINKLERS AND STANDPIPES – 15 HOURS

This certification-related course will discuss and detail operations regarding set up and supply operations for pump operators for sprinkler systems and wet and dry standpipe systems. It will include a review of control valves, pressure settings and operations procedures. This Pumps Sprinklers & Standpipes (Chapter 05) course is part of the Pumps Certification Program approved by the NC Fire and Rescue Commission for offering as of July 1, 2017.

Schedule: Saturday, Mar. 3, 8 am – 5 pm  
Sunday, Mar. 4, 8 am – 5 pm

Requirements: Students will need note taking material.

### 2. MAYDAY – 8 HOURS

This certification-related course will present the firefighter candidate with the knowledge, skills, and ability to satisfy the requirements of Chapters Five and Six of NFPA 1001: Standard for Firefighter Professional Qualifications. By using simulated situations, this course focuses on identifying parameters that constitute a mayday call.

Schedule: Sunday, Mar. 4, 8 am - 5 pm

Requirements: Students will need full PPE, Air Pack and Spare Cylinder

### 3. HEALTH AND WELLNESS – 8 HOURS

This certification-related course will present the firefighter candidate with the knowledge, skills, and ability to satisfy the requirements of Chapters Five and Six of *NFPA 1001: Standard for Firefighter Professional Qualifications*. This course is designed to educate first responders on the importance of maintaining high levels of fitness and wellness in order to perform their assigned duties efficiently and safely. This course is part of the NC Firefighter Certification Program approved by the NC Fire and Rescue Commission for offering as of January 1, 2015.

Schedule: Saturday, Mar. 3, 8 am - 5 pm

Requirements: Students will need note taking material.

### 4. TRAFFIC INCIDENT MANAGEMENT – 4 HOURS

This course is designed to establish the foundation for and promote consistent training of all responders to achieve the three objectives of the Traffic Incident Management (TIM) National Unified Goal: responder safety; safety, quick clearance from incidents; and prompt, reliable, interoperable communications. This course will familiarize fire and rescue personnel with the purpose of the Strategic Highway Research Program 2 (SHRP2) and National TIM Responder Training Program and how it relates specifically to North Carolina. Participants will learn to recognize and identify the dangers encountered by emergency responders working in or near traffic. This course is not a state fire & rescue certification course; however, it is a requirement related to one or more state certifications and will transfer electronically to the Office of State Fire Marshal (OSFM) for inclusion on OSFM transcripts. Please contact OSFM for details.

Schedule: Friday, Mar. 2, 6 pm - 10 pm

Requirements: Students will need note taking material.

### 5. LP GAS TRAINING – 16 HOURS

This course deals with preparing the firefighter to respond to and contain flammable liquid fires such as hydrocarbons.

Schedule: Saturday, Mar. 3, 8 am - 5 pm  
Sunday, Mar. 4, 8 am – 5 pm

Requirements: Students will need full turnout gear and SCBA with spare cylinder. Students will also need a letter from their department for participation.

### 6. TRAINING OPERATIONS IN SMALL DEPARTMENTS – 12 HOURS

This course is designed to provide the student with the essential tools and skills to lead and manage a training program in a small department. It is not designed specifically to enhance development or presentation skills, nor is it related to the public education discipline.

Schedule: Saturday, Mar. 3, 8 am – 5 pm  
Sunday, Mar. 4, 9 am – 1 pm

Requirements: Students will need note taking items.

### 7. EMERGENCY VEHICLE DRIVING – 20 HOURS

This course deals with the safe operation of emergency vehicles, driving skills, legal implications of emergency driving and departmental standard operating procedures. This is a NC Fire and Rescue Commission certification course.

Schedule: Friday, Mar. 2, 6 pm – 10 pm  
Saturday, Mar. 3, 8 am – 5 pm  
Sunday, Mar. 4, 8 am – 5 pm

Requirements: Students will need note taking items and must possess a valid driver's license.

## CLASSES

### 8. PORTABLE EXTINGUISHERS – 8 HOURS

This certification-related course will present the firefighter candidate with the knowledge, skills, and ability to satisfy the requirements of Chapters Five and Six of NFPA 1001: Standard for Firefighter Professional Qualifications. This course is designed to cover the extinguishing characteristics of portable fire extinguishers. This course is part of the NC Firefighter Certification Program approved by the NC Fire and Rescue Commission for offering as of January 1, 2015.

Schedule: Sunday, Mar. 4, 8 am - 5 pm

Requirements: Students will need full turnout gear and air pack.

### 9. DECISION MAKING FOR INCIDENT COMPANY OFFICERS (DMICO) – 16 HOURS

This two-day course is designed to develop the decision making skills needed by Company Officers (COs) to accomplish assigned tactics at structure fires. All activities and scenarios used in this course are based on structure fires. With the real possibility of being the first to arrive at an incident, the CO's initial decisions will have an impact throughout the entire incident. It is vital that COs be able to make good management decisions that have a favorable impact on the eventual outcome. In addition to a possible role as the initial Incident Commander, the CO may well be assigned a subordinate position within the Incident Command System organization. COs need to have a clear understanding of the system, the position that they are assigned to, and their role in the organization if they are to function effectively and help make the system work.

Sunday, Mar. 4, 8 am - 5 pm

Requirements: Students will need note taking items.

### 10. INITIAL FIRE INVESTIGATIONS FOR FIRST RESPONDERS – 15 HOURS

This two-day course is designed specifically to provide a clear definition of the role of first responders in fire investigation and provide essential knowledge to enable them to recognize the potential of intentionally set fires, preservation and protection of evidence, and proper reporting of information to appropriate officials. By strengthening the partnership between first responders and investigators, the chances for successfully solving arson-related crimes will increase. The course includes topics such as fire behavior, critical observations of the first responder, fire causes, scene security and evidence preservation, legal considerations, and documentation of findings.

Schedule: Saturday, Mar. 3, 8 am - 5 pm

Sunday, Mar. 4, 8 am - 4 pm

Requirements: Students will need note taking items. Book will be provided.

## CLASSES

### 11. PTSD AND LOCATION ACCURACY – 4 HOURS

The industry has been talking about Next Generation 9-1-1 for over a decade now, and PSAPs and the general public have been promised major improvements: more accurate location information, location-based call routing, multimedia to the PSAP and much more. Citizens are used to smartphones and expect more and more innovation from public. While most of the country is still undergoing major upgrades to their network and telephony infrastructure, this session looks at the more practical aspects for PSAP managers, supervisors, responders and Telecommunicator. It will focus on what you in the PSAP need to know, and more importantly, what you need to do.

#### **PTSD, Who ME? Yes, YOU!**

Post-Traumatic Stress affects everyone in the public safety circle, including telecommunicator. However, it does not always start in the Communications Center, but it sure can end up there. This session will take a look at where post-traumatic stress starts and where it has the potential to end. We will learn about the PTSD time line that includes the events leading up to, warning signs, diagnosis, ways to get help and how to have it but not let it have you!

Schedule: Saturday, Mar. 3, 8 am - Noon

Requirements: Students will need note taking items.

### 12. NFPD/ISO AS IT PERTAINS TO 911 – 4 HOURS

This session will discuss the current NFPA Standards and the role they play with the operations of your local 911 center. The relationship between ISO and these NFPA standards. How to get the maximum points from the communication center to help lower your fire departments public protection rating. Passing the savings to your local business and homeowners insurance. This session is recommended for Fire Service Chief Officers, 911 center Directors, Staff, and Emergency Management officials who have communication responsibilities.

Schedule: Saturday, Mar. 3, 1 pm - 5 pm

Requirements: Students will need note taking items.

### 13. A VICTIM'S PLEA, MEETING EXPECTATIONS- DENISE AMBER LEE FOUNDATION - 8 HOURS

TNathan Lee, founder and President of the Denise Amber Lee Foundation join forces with an industry professional to tie together the elements of the Denise Amber Lee tragedy. Students learn of the obvious failures that day to the more in-depth concepts such as leadership, hiring, training and encouraging employees in a communications center.

Schedule: Sunday, Mar. 4, 8 am - 5 pm

Requirements: Students will need note taking items.

### 14. ADVANCED CARDIAC LIFE SUPPORT (RECERTIFICATION) – 8 HOURS

This course follows the standard American Heart Association guidelines. It provides physicians, nurses, paramedics and other health care providers with information concerning advanced management of the cardiac patient.

Schedule: Saturday, Mar. 3, 8 am – 5 pm

Requirements: Students will need to pay a \$6 fee at start of class for card.

### 15. PEDIATRIC ADVANCED LIFE SUPPORT (RECERTIFICATION) – 8 HOURS

The PALS course is designed to certify Emergency Medical Personnel in Pediatric Advanced Life Support through the American Heart Association. This course teaches the proper evaluation and treatment of a pediatric patient in cardiopulmonary arrest. Upon successful completion, the student will be awarded PALS certification from the American Heart Association. Pre-requisite: It is desirable but not required that an ALS certification be held.

Schedule: Sunday, Mar. 4, 8 am – 5 pm

Requirements: Students will need to pay a \$6 fee at start of class for card.

### 16. AHA BLS CPR – 4 HOURS

This class is a four hour class that will meet objectives for initial or re-certifications. Each participant must complete and pass the skills and final written test for certification. There is a \$5 card fee that must be paid after successful completion of the class. This course is a hands on course that is limited to the first 9 registered participants.

Schedule: Saturday, Mar. 3, 8 am – Noon

### 17. EKG REVIEW – 4 HOURS

This class will review the electrophysiology of the heart along with basic rhythms. You will review ECG's and 12 leads that will lead to case studies and discussions. STEMI imposters and medication review will also be discussed.

Schedule: Saturday, Mar. 3, 1 pm – 5 pm

### 18. DIFFICULT AIRWAY CLASS – 8 HOURS

This course prepares an individual to safely manage and correct a difficult airway. BIAD, Intubation, and surgical airway skills will be completed in this course with the use of pig tracheas. This course is a hands on course that is limited to the first 12 registered participants.

Schedule: Saturday, Mar. 3, 8 am – 5 pm

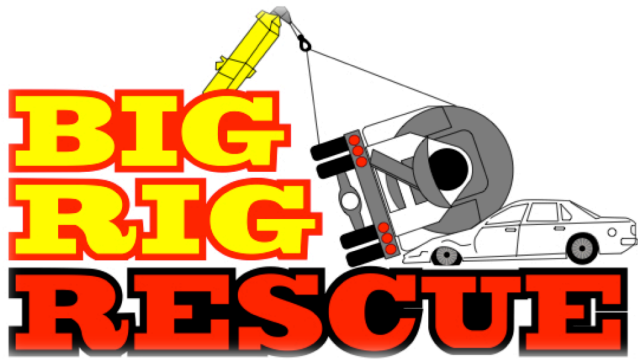
