The instructions below apply to the student and spouse, (if married). An IRS Tax Return Transcript and/or other IRS documents such as IRS Verification of Non-filing may be obtained free of charge in several ways; be sure to request an IRS Tax Return Transcript and not a “Tax Account Transcript”:

- On-line at www.irs.gov under “**Get Your Tax Record**” with two options “Request Online” or “Request by Mail”. **Note:** If at any point you cannot validate your identity using the “**Request Online**” option, you may use the “**Get Transcript by Mail**” option. This will be mailed to the address on the tax return within 5 to 10 business days.
- Contact the **IRS Transcript Request Line at 1-800-908-9946** (this is an automated service).
- **Visit the regional IRS Office** located at 2835 S. Charles Blvd., Greenville NC 27858. **Note:** You must make an appointment before visiting by calling **1-844-545-5640**.
